However, it should be noted that military activity will still be conducted in VMC. In the event of an emergency which requires airborne assistance the HRA will be cleared of military low flying aircraft. Clearance for emergency services aircraft to enter the HRA will be given by Scottish Area Control Centre in conjunction with the LFBC and Kinloss Aeronautical Rescue Co-ordination Centre. 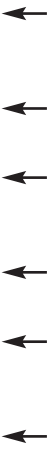
